## General Conditions

**Deposit Requirements:** A deposit of \$300.00 (in US funds) is required to secure accommodations. Personal checks, money orders, and credit card (MC/Visa/Discover) payments are accepted. Deposits are accepted on a "first come" basis and availability is limited. The final balance is due by May 30, 2017. Reservations made after May 30, 2017 will require full payment at the time of booking.

**Cancellations and Refunds:** All cancellation requests must be addressed to Templeton Tours in writing. Cancellation fees will be charged as follows:

- \$95 per person administrative fee when canceled more than 75 days before sailing.
- 50% of cruise fare when canceled 74-30 days of sailing.
- No refund for no-shows or when canceled within 30 days before sailing.

Airline ticket cancellation is subject to the cancellation policy of the specific airline. In most cases tickets are non-refundable. Trip cancellation insurance is recommended.

**Identification:** All U.S. passengers are required to present proof of citizenship in the form of a valid passport, or a certified birth certificate along with a government issued photo ID such as a driver's license. For more information or to obtain a passport application, visit [www.travel.state.gov](http://www.travel.state.gov). Passengers denied boarding are not eligible for a refund. All non-U.S. Citizens should contact their respective embassies or U.S. & Canadian Immigrations for applicable regulations. Children under 18 years of age traveling without both parents must bring a notarized letter of consent from the absent parent(s), giving permission for them to leave the country with a specified adult guardian.

**Embarkation:** The Norwegian Jewel sails from Seattle, Washington at 4:00PM on Saturday, July 29, 2017. Embarkation begins at 11:00AM. You must be on board no later than 2 hours before sailing.

**Disembarkation:** The Norwegian Jewel returns to Seattle, Washington at 8:00AM on Saturday, August 5, 2017. Allow 1-2 hours for disembarkation, customs and immigration formalities.

**Fare Inclusive:** Your cruise rate includes ocean transportation, accommodations, entertainment, service and meals, and port charges. Prices are from Seattle, Washington in U.S. funds.

**Accommodations:** Prices are based on two full-paying passengers per cabin. Single cabins are available at 200% of the category price. Third and Fourth passengers in a cabin pay \$1095 per person.

**Cruise Baggage Allowance:** 2 medium suitcases, 1 carry-on bag per person.

**Not Included:** Air transportation and transfers to the port of departure, gratuities, optional shore excursions, and items purchased on board.

**Disabilities/Pregnancy/Infants:** Norwegian Cruise Line recommends that guests with disabilities complete a Special Requirements Information (SRI) form at the time of booking in order to prepare for the guests' arrival. Guests who are unable to care for their basic needs (e.g. dressing, eating, and attending safety drills) MUST have a capable traveling companion. Call Templeton Tours to request an SRI Form. NCL will not accept reservations for infants less than 6 months of age on the date of sailing, or women who have begun their 24th week of pregnancy at any time before or during the cruise. Please notify us if you are pregnant.

**Passage Contract:** The attention of the passengers is specifically directed to the conditions of transportation set forth in the passage contract of the ticket of NCL General Sales Agents and Operators. NCL reserves the right to alter the itinerary or substitute vessels if deemed necessary.

**Gratuities & Fuel Surcharges:** All passengers will be charged gratuities regardless of age. Gratuities for your cabin steward, waiter, busboy, and Maitre d' will be added to your onboard statement from NCL (\$94.50). Templeton Tours reserves the right to pass along any increase in fuel surcharges imposed by the cruise line.

**Responsibility:** Norwegian Cruise Line and Templeton Tours Inc. (TTI) expressly disclaim any responsibility for personal injury or property damage arising out of the acts or negligence of any air carrier, hotel, or any other person rendering any of the services offered in addition to the ship's cruise and shall not be responsible for any damage or inconvenience caused by late air, car or motorcoach arrivals nor for loss or damage to baggage, automobiles or other property of the passenger occurring off the vessel.
